Welcome to the Burnet County Area Fair! "No Time Like Fair Time"

The Burnet County Area Fair cordially invites citizens in Burnet County, as well as the adjacent counties (Bell, Blanco, Lampasas, Llano, San Saba, Travis, and Williamson) to enter and participate in our Fair!

The Burnet County Area Fair is a presentation of the Texas A&M AgriLife Extension Service of Burnet County, including the Highland Lakes Master Gardener Association, the Texas Extension Education Association of Burnet County, the Hill Country Sewing Group, the Highland Lakes Quilt Guild, the Bluebonnet Button Club and the dedicated Fair Board. We hope you'll be a part of this event.

Please note we have a Silver Star category for our senior citizens who would like to display something they have made. Every item will receive a ribbon, but items will not be judged. We feel that there are many homebound and assisted living citizens who still enjoy doing handiwork or painting, etc. We invite you to enter the Fair and let everyone see what you love to produce.

Early registration for the 2025 Fair will take place *Wednesday*. Quilts and Creative Writing only will register from 9:00 a.m. – 6:30 p.m. All other divisions will begin early registration from 4:30 - 6:30 p.m. Registration for all divisions except Quilts and Creative Writing will continue *Thursday* from 9:00 a.m. until 12:00 noon. We hope these hours will be convenient for our exhibitors, especially those who work during the day. Judging will begin for Quilts and Creative Writing at 9:00 a.m. and all other divisions at 1:00 p.m. on Thursday and the show hall and gym will be *closed* to the public during judging and tabulation of winners.

The Fair will then open its doors to the public on *Friday morning* at 9:30 a.m. for the Opening Ceremonies. A special awards ceremony will be held at 5:30 p.m. Friday evening in Burnet County AgriLife Auditorium to honor Best of Division, Sweepstakes, and People's Choice Award winners in all three age groups.

This year's theme is "No Time Like Fair Time," and the Fair features 18 divisions. While *all* divisions in the Fair adhere to certain general rules listed on **page 5**, and award the same prizes, the rules for individual divisions may differ somewhat. On the pages that follow, both General Rules and division-specific rules are listed. **Please read all carefully** as new categories may have been added to several divisions.

On Friday afternoon we will have the ice cream crank-off followed by a food demonstration. Knowledgeable volunteers will be on hand all day, both Friday and Saturday, to answer questions about exhibits on display, the Fair and its history, and how to become involved with the Fair. We are always in need of new and younger volunteers to keep the Fair going and updated.

Once again, the Fair will offer cash prizes for first, second, and third place winners, Best of Division winners, and Sweepstakes Award winners. The Sweepstakes Award will be given to the exhibitor in each age group who enters exhibits in three or more Divisions and earns the most points. Also, a "People's Choice" award will be given in all three age groups. This award is voted on from among <u>all</u> Divisions by visitors to the Fair, and the winner in each age group receives a plaque.

Once again we will be presenting a scholarship for any high school graduating senior in Burnet County, whether you are in public, private, or home school. The application will be placed on the website and available at the AgriLife Extension office. Applicants must have been active in the Fair, either by entering items to be judged or helping in some way with the fair. This scholarship is named the Rosalyn Lackey Memorial Scholarship in her memory. It will be presented on Friday evening during the awards ceremony.

All exhibits must be picked up on Saturday between 3:30 and 4:30 p.m. Silent auction items must be picked up at this time. There will be <u>no</u> pick-up of entries or winnings on Sunday!

General Rules

NOTE TO EXHIBITORS

Please read *ALL* the General Rules (below) before submitting exhibits!

Each Division has its own specific rules as well, outlined in the pages that follow.

General Rules apply to *all* Divisions without exception.

- 1. All exhibitors must be residents either of Burnet County or of adjacent counties: Bell, Blanco, Lampasas, Llano, San Saba, Travis, and Williamson.
- In each division, entries are judged in three separate age groups as follows: ADULT (18 years and older), SENIOR YOUTH (12-17 years), and JUNIOR YOUTH (younger than 12 years). In this way, youth compete against other youth, not against adults, and there are <u>three</u> Best of Division winners, one for each age group.
- 3. ALL entries must have been made by the person entering the item! All entries must have been completed in the last 12 months (June 2024 June 2025). Entries from previous years are not eligible for exhibition and will not be accepted.
- 4. Entries are limited to one item per category per exhibitor. In *some* divisions (but not all), more than one entry per category is permitted: see individual division rules. In these cases, the division rules take precedence. For example, if an exhibitor in the Preserved Foods Division wanted to enter the Jelly Category with both grape jelly and strawberry jelly, that would be acceptable because those are different kinds of Jelly. For questions, contact the Division Superintendent *prior to* Fair registration.
- 5. No entries from professionals will be accepted. In general, a professional is defined as an adult who earns more than 40% of his/her income in one of the various divisions listed in these rules. Being a professional in one division, however, does not preclude that person from entering another division. Different divisions may have different definitions of "professional" (e.g., Photography). When in doubt, check with the Division Superintendent.
- 6. No Division Superintendent of the Burnet County Area Fair shall enter an exhibit in his/her own division. Superintendents *may*, however, enter exhibits in *other* divisions and be eligible to win ribbons.
- 7. The Burnet County Area Fair reserves the right to accept or reject any exhibit or entry.
- 8. The pink, blue, or yellow four-digit entry tag must remain attached to the exhibited article for the duration of the Fair.
- 9. Exhibitors must always give the necessary attention to all their entries and take possession of those items at the close of the Fair.
- 10. No entries will be removed before the designated pick-up time (Saturday, June 14, 3:30 p.m. 4:30 p.m.).
- 11. Awards are given solely as recognition of merit and will be based upon the decisions of the judges. Entries not warranting an award in the opinion of the judges will not receive an award even if there is no competition in that category. Lack of competition shall not be the cause of withholding a prize. The decisions of the judge(s) are final, and no appeals will be heard concerning the placing.
- 12. The Burnet County Area Fair reserves the right to interpret these rules and to settle all questions arising in connection with the Fair.
- 13. In no case will the Burnet County Area Fair be responsible for any accident, damage, or loss of any property.

AWARDS

First-, second-, and third-place ribbons may be given in each age group in each exhibit category of the exhibit divisions. A small cash prize will be given for each place award as follows: \$3.00 for first place, \$2.00 for second place, and \$1.00 for third place. A Best of Division award will be given for each age group in each exhibit division. In addition to a special rosette ribbon, the Best of Division award will include a small cash prize of \$5.00.

SWEEPSTAKES AWARD

The **Anne Mae Glimp Sweepstakes** award will be given for each age group. To be eligible for the Sweepstakes award, an exhibitor must enter an item in three or more divisions (<u>NOT</u> CATEGORIES WITHIN A DIVISION). A point system based on the ranking of an exhibitor's entry within each division will be used to determine the Sweepstakes winner in each age group. The point system is as follows: **1** point for each entry; **5** points for each 3rd-place ribbon; **10** points for each 2nd-place ribbon; **15** points for each 1st-place ribbon; and **25** points for each Best of Division rosette.

PEOPLE'S CHOICE AWARD

The **Frances Reed, People's Choice** award for each age group will be voted on by Fair visitors and a plaque will be given to the winner at the awards ceremony Friday evening. Ballots are made available to those viewing fair entries on Friday. Containers are available at the front table for ballots to be placed.

SPIRIT AWARD

The **Edna Niebanck Spirit Award** will honor **a** junior or senior exhibitor who emulates Edna's love, enthusiasm, and fun spirit for all aspects of the county fair. The nominees will be determined by the division superintendents as they observe the enthusiasm of youth who participate in all aspects of the fair. These characteristics will include helping, volunteering, excitement in entering, and courteousness during the fair and good sportsmanship in the results.

This award is in honor of Edna Niebanck, a former member of the Redbud-Oakalla Extension club. Growing up in Sussex County, New Jersey she was very active in 4-H and the county fair while raising her daughter. Later in life she moved to Burnet County, Texas to live with her daughter and they continued their love of the county fair. Every year, the planning of projects to enter and the excitement of waiting for the judges' decision on their entries was a highlight of their summer. Quite often competing against one another and their friends made it even more fun. At Edna's passing in September 2024, at the age of 97, the Redbud-Oakalla Extension Education Club, where Edna was a member, created this award to honor Edna's memory and her love, enthusiasm, and fun spirit in entering and competing in the fair. This award is not determined by the entry but rather by the individual who enters the fair.

Any prize money not claimed by July 31, 2025 will be forfeited and returned to BCAF treasury.

SCHOLARSHIP

A scholarship for any high school graduating senior in Burnet County, whether in public, private, or home school will be presented Friday evening during the awards ceremony. The application will be on the website and available at the AgriLife Extension office. This scholarship is named the **Rosalyn Lackey Memorial Scholarship** in her memory.

- 2. Wall art articles must be appropriately prepared for hanging or they may be disqualified.
- 3. General appearance: Articles must show good design and color for intended use.
- 4. Workmanship must be of high quality with attention to details.

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

Submission Rules for Baked Goods

- 1. All Baked Goods will be judged on Presentation (30%), Recipe (10%), and Taste and Texture (60%) unless otherwise specified in the category description. All items will be cut/sliced as part of judging.
- 2. Each entry must be accompanied by the recipe. Recipes must be neatly handwritten or typewritten and must have a complete list of all ingredients that were used, as well as detailed preparation and baking instructions. The printed copies of the recipe become the property of the Burnet County Area Fair, which has the right to use the recipe(s) for fair publicity. DO NOT put the name of the exhibitor on the recipe.
- 3. All entries will remain intact and on display for the duration of the fair. Items are to be picked up at the close of the fair on Saturday afternoon at the designated pick-up time in GENERAL RULES.
- 4. All entries must be the work of the exhibitor. All entries must be submitted on a sturdy white paper or foam plate unless otherwise noted. Each entry is to be sealed in a gallon zip bag or covered with transparent or clear plastic wrap.
- 5. All entries must be made from scratch except for those indicated otherwise.

Food Safety Rules

Since entries will be tasted by the judges, fillings, frostings, glazings and meringues (whether uncooked or cooked) are not permitted to contain cream cheese, whipped cream, sour cream, unpasteurized milk, or raw eggs due to health reasons. Exhibitors should carefully wash their hands and make sure that their hands do not have any open cuts before preparing food. Baked Goods should be delivered in covered containers, plastic wrap, or a zip bag.

BAKED GOODS: CATEGORIES

CATEGORY 1: CAKE

CATEGORY 2: DECORATED CAKE

Cake is to be 1 layer high, 8x8" or nine-by-nine", square or round. Cake will not be judged for taste - either box or scratch will be accepted. Frosting will be tasted. Recipe is not required. Frosting will be judged on Technique (40%), Taste (20%), and Appearance (40%). Cake can either remain in pan and frosted only on top or removed from pan and entirely frosted.

CATEGORY 3: CUPCAKES (6 each)

CATEGORY 4: DECORATED CUPCAKES (6 each)

Decorated cupcakes will not be judged for taste – either box or scratch will be accepted. Frosting will be tasted. Recipe is not required. Frosting will be judged on Technique (40%), Taste (20%), and Appearance (40%).

CATEGORY 5: COOKIES - BAR COOKIES (6 each)

Cookies that are baked in a pan and then cut into individual bars. Examples - brownies, lemon bars, date bar cookies, toffee bar cookies.

CATEGORY 6: COOKIES - DROP COOKIES (6 each)

Cookies that are made by dropping a spoonful of batter on a cookie sheet for baking. Examples - chocolate chip cookies, cranberry cookies, sugar cookies.

Division 2 – Baked Goods continued

CATEGORY 7: COOKIES - FORMED OR MOLDED COOKIES (6 each)

Cookies that are molded or formed by hand or pressed into a mold before baking. Examples, gingerbread cookies, Christmas tree cookies.

CATEGORY 8: COOKIES - NO-BAKE (6 each)

Cookies that are a hybrid between a candy and a cookie. No-bake cookies are unique among types of cookies in that they do not require baking time in an oven. Examples – peanut butter no-bake cookies, oatmeal chocolate no-bake cookies, no-bake butterscotch cookies, chocolate hazelnut no-bake cookies.

CATEGORY 9: CANDY (6 pieces)

CATEGORY 10: PIES AND COBBLERS

Crust recipe must be included in the recipe. No store-bought crusts may be entered in this category.

CATEGORY 11: ALMOST FROM SCRATCH PIES AND COBBLERS

Crust may be store-bought or a mix.

CATEGORY 12: QUICK BREADS

Breads made with a chemical leavening agent (such as baking powder or baking soda).

CATEGORY 13: MACHINE BREADS

Breads made with an appliance that turns raw ingredients into freshly baked bread.

CATEGORY 14: YEAST BREADS

Breads made using yeast as a leavening agent.

CATEGORY 15: ARTISAN BREADS

Artisan bread is handmade with more traditional processes, in small batches and typically uses traditional yeast fermenting techniques. Please provide concise directions on the ingredients and the process of making this bread.

CATEGORY 16: SMALL BAKED GOODS

Rolls, biscuits, muffins, pastries, turnovers, crackers (6 each)

CATEGORY 17: ALMOST FROM SCRATCH

Item in any category except category 11 which is made from a mix but with at least two additional ingredients – same quantity requirements apply as for the original category.

CATEGORY 18: SPECIALIZED BAKING

Any baked good addressing special dietary needs – i.e., Paleo, Vegan, Gluten-Free, Dairy-Free, Diabetic (Sugar-Free)

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

Submission Rules for Buttons

- 1. Old or new sewing buttons should be used prominently in each entry.
- 2. Flat pieces should be mounted on mat board or foam board and have a hanging tab.
- 3. Workmanship should be of high quality with attention to detail.
- 4. Items which are embellished with buttons by the exhibitor do not have to be made by the exhibitor (for example: garments, dolls, and stuffed animals) but may be so.
- 5. You may have only one (1) entry in each category.

CATEGORIES

CATEGORY 1:COLLAGE on 9x12-inch mat board or foam board using at least 3 sewing buttons. The theme of the collage is "NO TIME LIKE FAIR TIME" (Please provide hanging tab.)

CATEGORY 2:BUTTON JEWELRY

CATEGORY 3:EMBELLISHED GARMENT

CATEGORY 4:HOLIDAY CRAFT USING BUTTONS

CATEGORY 5:STUFFED ANIMAL OR DOLL USING BUTTONS

CATEGORY 6:BUTTON COLLECTION: Collection of **10** buttons displayed on a 9x12-inch mat board or foam board. Buttons should show a commonality such as 10 buttons made from the same material, or 10 buttons showing animals or plants, or 10 buttons showing different shapes. Label the theme of the collection (the common factor).

Members of local, state, or national button clubs may not enter this category.

CATEGORY 7:BUTTON COLLECTION: Collection of **20** buttons displayed on a 9x12-inch mat board or foam board. Buttons should show a commonality such as 20 buttons made from the same material, or 20 buttons showing animals or plants, or 20 buttons showing different shapes. Label the theme of the collection (the common factor).

Members of local, state, or national button clubs are eligible to enter this category.

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

Submission Rules for Clothing

- 1. Garments and wearable items are to be made from fabric or leather and must have been made by the exhibitor within the past 12 months (since mid-June 2024).
- 2. Judging will be done on appearance, construction, workmanship, seams straight, neatness, threads clipped, and good sewing techniques.
- 3. General appearance criteria:
 - a. Attractive fabric suitable for the purpose of garment
 - b. Well pressed and clean
 - c. Current styling or good basic style
 - d. Trimmings and findings attractive
 - e. Pleasing color or color combinations
 - f. Correct grain lines, matched plaids or stripes if applicable
 - g. Thread and notions matched to fabric as closely as possible.
 - h. Professional-looking finish
 - i. Hems and facings inconspicuous from the garment's right side
 - j. Linings, interfacings and/or under linings should not add excess bulk or cause unsightly wrinkling.
- 4. All garments and wearable items must be on hangers.
- 5. If the garment was made from a pattern, the pattern must be submitted in an envelope affixed to the garment. If *not* made from a pattern, the garment or wearable item should have affixed to it an index card reading "Original Design."
- 6. Under General Sewing criteria:
 - a. Attractive fabric suitable for the items
 - b. Well pressed and clean
 - c. Thread and notions matched to fabric as closely as possible.
 - d. Professional-looking finish

Submission Rules for General Sewing

Criteria specific to General Sewing:

- a. Attractive fabric suitable for the items
- b. Well pressed and clean
- c. Thread and notions matched to fabric as closely as possible.
- d. Professional-looking finish

CATEGORIES - GENERAL SEWING

CATEGORY 1: KITCHEN ITEM OR SET OF ITEMS (2 or more match, e.g., stand mixer cover and toaster cover) (NOTE: This category excludes Aprons!)

CATEGORY 2: PILLOWS

CATEGORY 3. WALL HANGINGS (no larger than 48" x 36")

CATEGORY 4: TABLE RUNNER

CATEGORY 5: OTHER

Submission Rules for Creative Writing

In 2025, requirements for Creative Writing submissions differ from those in 2024. This year, there are only two categories within each of three age groups: Category 1, Poetry, and Category 2, Prose, both having content related to the 2025 Fair Theme: "NO TIME LIKE FAIR TIME."

Writing submissions will be accepted <u>ALL DAY</u> on Wednesday, June 11, from 9:00 a.m. until 6:30 p.m. Creative Writing entries will **NOT**, however, be accepted on the following day, Thursday, June 12.

Instead, Creative Writing entries will be <u>JUDGED</u> on Thursday, June 12. Because judging requires 6-7 hours, the deadline for Creative Writing entries has been moved to Wednesday, June 11, at 6:30 p.m., allowing sufficient time on Thursday for judges to read and discuss all entries before they reach consensus. Awards must then be certified by Fair personnel. The Wednesday deadline is firm: <u>NO</u> exceptions will be made for entries presented on Thursday, June 12!

Please read carefully the statements that follow, which apply equally to all three age groups and to both categories:

CREATIVE WRITING: CATEGORIES

CATEGORY 1: POETRY BASED ON THE 2025 FAIR THEME, "No Time Like Fair Time" CATEGORY 2: PROSE BASED ON THE 2025 FAIR THEME, "No Time Like Fair Time"

REQUIREMENTS FOR **GENRE, LENGTH, AND CONTENT** OF ENTRIES:

- 1. Poetry entries are limited to <u>one</u> (1) per Category, maximum length of 28 lines. Poems may rhyme, or they may be free verse; they may either follow traditional forms (sonnet, villanelle, quatrain, tercet, haiku, etc.) or not.
- 2. Prose entries are limited to <u>one</u> (1) per Category, maximum length 500 words. Prose entries may be articles, editorials, essays, short-short stories, flash fiction, journal entries, memoirs, and the like.
- 3. For prose entries, do not count the title as "words." For poetry entries, do not count the title, blank spaces after it, or blank spaces between stanzas.
- 4. All subject matters must be suitable for exhibition to a general audience, including children.
- 5. The content of both poetry and prose should describe, or at least be evocative of, county and regional fairs, their place in communities, and the feelings they engender.
- 6. <u>VERY IMPORTANT</u>: The Fair assumes that all compositions submitted are the original work of their authors. <u>Neither</u> Al nor any other form of plagiarism is allowed. Any entry deemed not to have been written solely by its exhibitor will be disqualified!

Division 5 — Creative Writing, Continued

REQUIREMENTS FOR **PREPARATION** OF ENTRIES:

- Contestants must prepare <u>three</u> (3) identical hard copies of their submission in <u>each</u> category. Only <u>one</u>
 submission per category is allowed. <u>NO</u> electronic copies will be accepted.
- 2. All entries must be typewritten or computer-generated on standard letter-size (8.5 x 11-inch) white paper, preferably 20-lb or 24-lb.
- 3. Margins must be <u>1 inch</u> on all four sides.
- 4. The font recommended for use is 12-point Times or Times New Roman. Arial (12-point) and Courier (10-point) are also acceptable.
- 5. Prose entries must be <u>double-spaced</u>. Poetry entries may be space-and-a-half.
- 6. Printing must appear on <u>only one</u> side of the paper, not both.
- 7. For multiple-page entries, pages must be numbered.
- 8. Multiple-page entries must be *paper-clipped* together. Stapled entries will be disqualified!
- 9. The author's name must NOT appear on any of the three identical hard copies submitted!

REQUIREMENTS FOR SUBMISSION OF ENTRIES:

- <u>ALL</u> entries in the Creative Writing Division must be submitted *in person* at the Burnet County Area Fair at the Texas A&M AgriLife Office, 607 North Vandeveer Street, Burnet, Texas, on Wednesday, June 11, 9:00 a.m. – 6:30 p.m.
- 2. Contestants must submit *three* (3) identical hard copies of each submission.
- 3. The author's name must not appear anywhere on the three hard copies that constitute an entry!
- 4. When entries are brought to the AgriLife Office, a registrar will provide the contestant with both a letter-size white "exhibitor form" and a smaller, color-coded "exhibitor tag" to fill out. These forms are the ONLY places the contestant's name can appear! This ensures that each entry will be judged in accordance with the rules of the Burnet County Area Fair. Adults will receive pink tags; Senior Youth, blue tags; and Junior Youth, gold tags. Exhibitor tags are randomly numbered, so those given to one individual are unlikely to be in sequence.
- 5. Only the Superintendent will know which tag number and exhibitor number correspond to each entry. Two (2) originals of each entry will be kept on file at the AgriLife Office: one for the Fair and one for the Highland Lakes Writers' Club. The third original will be photocopied, if necessary, to facilitate judging.
- 6. Judges *will not know* the identity of exhibitors. Entries will be identified *only* by exhibitor number and tag number.
- 7. If the contestant is entering other divisions besides Creative Writing, his/her exhibitor form must list <u>all</u> of the entries associated with that exhibitor number. Tags are issued at the Fair site on Wednesday, June 11, for entries in <u>all</u> divisions *including* Creative Writing and on Thursday, June 12, for divisions <u>other than</u> Creative Writing and Quilting. The contestant MUST return his/her completed exhibitor form before leaving the site of the Fair!
- 8. Members of the Highland Lakes Writers' Club, or others known to them (for example, teachers in local schools and colleges), will serve as judges. Most are published authors as well as long-time residents of the Texas Hill Country. In their evaluation of each entry, they will consider accuracy in spelling, diction, grammar, and punctuation, in addition to content and clarity of expression. The identity of contestants will not be known to judges until winners are announced publicly on the morning of Friday, June 13, 2025.

RETURN OF ORIGINAL SUBMISSIONS

Creative Writing contestants must pick up their entries on Saturday afternoon, June 14, 2025, between 3:30 and 4:30 p.m. At that time, copies of their entries will be returned to them, as well as ribbons, rosettes, certificates, cash awards, and other winnings they may have garnered.

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

Submission Rules for Fine Arts

- 1. All entries must be at least 100% done by the exhibitor.
- 2. Painting, including frame, may not be larger than 36" by 27". All framed paintings must be dry and substantially wired for hanging display.
- Exhibitors submitting porcelain arts entries (Categories 11 & 12) should provide a display easel or stand for each entry, if needed. Porcelain entries that are chipped or mended with glue will not be accepted.
- 4. Flat art pieces that do not require a frame, but that need to be hung for display, must be mounted on a foam core backing and must have a hanging tab that will support the weight of the piece.
- 5. All freestanding artwork must be substantial enough to be placed on a shelf or on the floor, depending on size of piece.
- 6. Entries must have been completed in the last year (June 2024–present).
- 7. Entries from the previous Burnet County Area Fair are not eligible to be submitted again.
- 8. The Fair Board reserves the right to reject work based on size, fragility, inappropriate content, or other rule infringements.
- 9. Seminar-, Class-, or Instructor-assisted submissions are eligible for Category 8 only.

Note: The Ice Cream Crank-off will be Friday, June 13, 2025, at 2:00 p.m. Entries **must be checked in** by 1:45 p.m. on that day! Exhibitors **must register** during registration hours on June 11th or June 12th and **must attach** the ice cream recipe(s) to the registration form.

Submission Rules for Ice Cream Crank-off

- 1. All entries containing milk and/or eggs must be pasteurized products. No raw eggs or fresh milk.
- 2. Ice Cream must be made from scratch and not purchased.
- 3. Ice Cream must be brought to contest already cranked and ready to be judged. DO NOT OPEN prior to arrival.
- 4. Any type of ice cream maker may be used.
- 5. At least a half-gallon of ice cream is to be presented.
- 6. You may enter as many flavors/categories as you like. Each will have a separate tag.
- 7. Entries will be judged on:

Recipe 20 points
Appearance & aroma 15 points
Texture 15 points
Taste 50 points

Judges reserve the right to refuse to taste any entry.

- 8. After judging is completed, samples will be provided to the public. No samples may be given out until the public tasting begins.
- 9. Entries are required to serve samples to the public. We recommend having a helper to assist you and promote your ice cream to the public.
- 10. For the public tasting, the Burnet County Area Fair will provide a zip lock bag which will contain a spoon, a napkin and a People's Choice ballot. Contestants will be provided with containers (2 oz.) in which to serve the ice cream.
- 11. Bring a serving spoon, a pan in which to set your ice cream freezer, additional ice to keep your ice cream frozen, and any other item(s) you may need. Tables will be provided by the fair.

Submission Rules for Patriotism

- 1. The entries for this Division must be made or assembled by the person entering the item(s), <u>EXCEPT in Category 9</u>, which can be any Patriotic item that was given to you by a friend or family member who served in the Military, with said item accompanied by a story.
- 2. The exhibitor can have only *one* (1) entry in each category, unless it's a set of items, for example, a tablecloth and napkins, or the Mother/Daughter Aprons Category (see Division 1), which requires two items.
- 3. All items can be made of purchased materials and assembled by the exhibitor.
- 4. General criteria:
 - a. Items are to be in good, clean condition; fabric items should be well pressed, with trimmings and findings attractive, pleasing color or color combinations, thread and notions matched to fabric as closely as possible, hems and facings inconspicuous from the right side, and a professional-looking finish.
 - b. Aprons, table runners, placemats, tablecloths, napkins, and pillows (pillow forms can be used) are to be of fabric and sewed by the exhibitor.
 - c. Attractive fabric suitable for the pattern should be used.
 - d. Table centerpieces shall not exceed 24 inches.
 - e. Wreaths shall be no larger than 36 inches.
 - f. All mechanics shall be inconspicuous.
 - g. All items must reflect the Patriotic theme of the Division.

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

(But please note <u>rule 7</u> below, an exception to the General Rules made for the Photography Division *specifically*)

- 1. Photography must be printed on photo paper.
- 2. The MAXIMUM size of a mounted photo must be 8 x 10 inches or 8 x 12 inches or 8 x 8 inches.
- 3. It is strongly recommended that ALL entries be 8 x 10 inches or 8 x 12 inches or 8 x 8 inches.
- 4. Photos must be mounted on study 8- x 10-inch or 8- x 12-inch or 8- x 8-inch backing <u>USING</u> mat board or foam core board. The quality of the mount will be considered in judging.
- 5. Photos smaller than the mounted board should be centered on the board.
- 6. Framed photos or matted photos are ineligible and will not be accepted.
- 7. Entries are limited to TWO photos per category per entrant.
- 8. Computer software may be used to enhance a photo—contrast, color intensity, etc. NO manipulation is allowed except for Category 5.
- 9. No entries from professionals will be accepted. Photographers earning more than \$6,000 a year from photography are considered professional.
- 10. All ribbon-winning photos will be exhibited from the opening of the Fair until the close of the Fair. Remaining entries will be displayed on a space-available basis.
- 11. All images must be suitable for exhibition to a general audience, including children.

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

Submission Rules for Potted Plants and Flowers

- 1. All entries in Potted Plants and Flowers must be the property of the exhibitor, who will in most cases have grown them. (See Rule 2 below.)
- 2. Plants and flowers used in designs (see Categories 11, and 14) must be fresh; however, they need not **necessarily** have been grown by the exhibitor.
- 3. All entries other than "Flower Arrangements" (Categories 11-13) potted plants, hanging baskets, dish gardens, and other must have been in the exhibitor's possession for at least six weeks, or since mid-April of 2025.
- 4. All entries other than "Flower Arrangements" should have been growing in their containers for at least six weeks, or since mid-April of 2025. The reason is that judges will consider the relative proportion of plant size to container size. Thus, if an exhibitor repots a plant in the early spring of 2025, that exhibitor should consider and plan for the likely growth of his/her plant by June 2025.
- 5. All entries must be clean and free of visible pests and/or spray residue, or they may be refused.
- 6. All containers must have the exhibitor's name and address attached in such a way that it will not be visible to the judges (e.g., a small printed return-address label on the bottom).
- 7. "Dish Gardens" should place greater emphasis on **horticultural specimens** than on fanciful or decorative elements.
- 8. All plants and cut specimens must be identified and labeled by the exhibitor!
- 9. Judging criteria for Potted Plants and Flowers include, but are not necessarily limited to: (a) overall health, appearance, and grooming; (b) color; (c) size; and (d) form, which includes such attributes as symmetry, proportion of plant to pot, substance, stems, foliage, and number and size of blooms if the entry is presented as a "flowering" potted plant or hanging basket.

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

Submission Rules for Preserved Foods (including Dried Foods)

- 1. Judging is based on current USDA approved processing methods and times, headspace, pack, uniformity of pieces, appearance of the product, liquid, and cleanliness of the jar and band. Headspace for each product varies. As a general rule, leave 1-inch headspace for low-acid foods, vegetables and meats; ½-inch headspace for high-acid foods, fruits, tomatoes, pickles and relishes; ¼-inch headspace for juices, jams and jellies; ¾ to ½ inch headspace for honey. Be sure to use the correct recommended headspace for each product. All exhibits must have been prepared by the exhibitor since June 2024.
- 2. All canned and dried products must be processed in compliance with the current USDA guidelines for safe food preservation and the Ball Complete Book of Home Preserving.
- 3. <u>All</u> canning must be in standard <u>Ball/Kerr</u> canning jars with a lid and band. All lids must have an airtight seal with ring intact, smooth, unbent and free from rust and corrosion.
- 4. All jelly, jam, preserves, and butters should be in a standard **Ball/Kerr** canning jar, with a lid and band. Leave the band on the jar. No paraffin seals will be accepted.
- 5. All containers must be sealed to be judged. No canned good will be opened or tasted.
- 6. <u>JAR TOPS</u> should be labeled with contents and dated. Exhibitor's name <u>MUST NOT</u> be included on the jar or the recipe.
- 7. A recipe specifying ingredients, directions and method of preservation <u>MUST</u> accompany all entries. The recipe should be submitted on a 5x7 note card or paper of the same size. Nothing larger will be accepted.
- 8. All canned goods except for honey and dried foods must be heat processed using either a boiling water bath or a pressure cooker, as appropriate. No open kettle method allowed.
- 9. The superintendent reserves the right to split categories if entries justify it.
- 10. The same item cannot be entered in more than one category, except for Category 1, Gift Container.
- 11. Unless otherwise noted, all exhibits must be in half-pint, pint, or quart jars.

QUANTITY REQUIREMENTS - DRIED FOODS

Exhibitor must have two submissions for each entered item.

Display entry use a standard canning jar with the lid and band. Use appropriate size container for type or size of dried food. Second submission - In a Ziplock bag place an adequate sample for judges to observe. Bags will be opened but will not be tasted.

General Rule #4 states that entries are limited to one entry per category per exhibitor.

Also, please note: With respect to set-up, registration, entry acceptance, and judging, the Quilting Division follows a schedule different from that for other divisions. Check the Fair's website, "Schedule of Events," for the Quilting Division schedule, or contact either of the two superintendents.

Submission Rules for Quilting

- 1. A quilt is defined as padding between two layers of fabric, held together by stitching (quilting) or tying.
- 2. Each entry must be the work of the person entering the item. Heirloom Quilts are the exception.
- 3. All Entries must be completed. No unfinished guilt tops will be accepted.
- 4. Wall Hangings must be less than 240 inches in circumference.
- 5. Miniatures must be no more than 60 inches.
- 6. Group quilts will be made by 2(two) or more persons. The person who quilted the quilt top is not included in this count.
- 7. The name or names of quilter, if known, can be included on the entry tag that will be attached to the exhibit item. Group Quilts can have group name.
- 8. Heirloom Quilts are approximately older than 50 years old. The quilt maker can be unknown or deceased.
- 9. The division Superintendent or Co-Superintendent reserve the right to change a quilted item's category.
- 10. Judges will consider the following criteria:
 - a. General appearance
 - b. Workmanship
 - c. Beauty and Design
 - d. Color harmony
- 11. Unjudged quilts will be quilts that the exhibitor wants to share with the Fair attendees. These quilts will not be judged.

PLEASE READ GENERAL RULES IN ADDITION TO THE RULES BELOW.

Submission Rules for Categories 1 through 6 - Storyboard Display

- 1. Storyboards are a visual way to communicate and share information with the general public.
- 2. Acceptable themes are the results of a project, an experiment, or the results of research done on a specific topic, character, or place.
- 3. All displays must be made on a Trifold Display Board measuring 36 by 48 inches maximum. The display board should fold out on the sides. No bigger size will be accepted. **The display board must be free-standing!**
- 4. The background can be any color.
- 5. All information must be attached to the board. (For Fair purposes, you may also place one or two items on the table, if space is available. For 4-H members, more information is available from the AgriLife Extension Office.)
- 6. Your display board must include the following:
 - a. Title of project
 - b. Identify your project or research. It should address a need.
 - c. What was the Goal? What were you trying to accomplish?
 - d. What was your Plan? What were the steps in accomplishing your goal? Did you need to include other people? How long did this take? How much did it cost? (if applicable)
 - e. Did you accomplish your goal? Write your conclusion.
- 7. You can incorporate some or all the following into the design of your display board:
 - a. Use bright and interesting colors.
 - b. Include graphs or interesting ways to convey your data.
 - c. Include photographs of your steps if appropriate.
 - d. Use graphics to explain items in Rule 6 above.
 - e. Be creative, as long as all illustrations are attached to the board.
- 8. Judging will be determined as follows:
 - a. 30 points—overall appearance and clarity
 - b. 20 points—organization of information
 - c. 20 points—use of graphics and photographs
 - d. 15 points—creativity, uniqueness
 - e. 15 points—conveyed the result or conclusion of the experiment/project, or the usefulness of the research.

NOTE: Rules 1 through 8 above apply to Category 1 and 2 (below), and to Categories 3, 4, 5, and 6 (on the following page). A *different* set of rules, given on the following page, governs *Category* 7, related to fashion.

Submission Rules for Category 7 - Fashion Design Boards

- 1. Fashion Storyboard tells a story of original designs using vivid images that are interesting and appealing to viewers. It conveys the designer's idea. It includes original illustrations and flats, as well as additional materials such as photos, fabric swatches, patterns, etc., that have influenced the unique design.
- 2. Only one per storyboard is permitted. Contestants may provide up to two (2) variations of the original design. (For 4-H members, more information is available from the website https://texas4-h.tamu.edu/wp-content/uploads/fashionstoryboard_guidelines_2025.pdf apply, except for the design brief, digital format and judging criteria.)
- 3. **NEW SINCE 2024:** All displays must be made on a Trifold Display Board measuring 36 by 48 inches maximum. The display board should fold out on the sides. No bigger sizes will be accepted. **The storyboard must be free-standing!**
- 4. Judging will be based on:
 - a. 20 points—Visual Appeal/Creativity of Storyboard. The storyboard should illustrate the theme, mood, or spirit of the idea.
 - b. 20 points—Quality of Workmanship. The storyboard should be neat and demonstrate high-quality workmanship throughout.
 - c. 20 points—Consistent Color Palette. A consistent color palette and theme should be used throughout the storyboard.
 - d. 20 points—Fabric Samples, Trims, and Embellishments must be included on the storyboard. (If exact fabric type cannot be found, then a "basic swatch" may be used—i.e., denim, linen, etc.)
 - e. 20 points—Design Detail—Should include at least one illustration and one flat.

- A. Wearable Clothing: Items which can be worn—pants, blouses, coats, skirts, dresses, sweaters, etc.

- 2. An insufficient number of specimens will disqualify the entry.
- 3. Exhibitors may enter as many varieties as they choose in each category. Examples are provided but not limited to these varieties. Varieties cannot be duplicated.
- 4. Judging criteria and guidelines are posted on the Burnet County Area Fair website under EXHIBITOR INFORMATION. It is very important to read both the GOALS FOR JUDGING and SCORESHEETS. This will assist you in understanding how your items are judged. The more you adhere to the criteria the better your score will be.
